## KEY:

### SALARIES

Salary figures in this report are quoted on basic salaries - other benefits including pension, childcare vouchers, private healthcare, and car allowances are not included.

Although compensation packages are a major consideration when attracting talent or changing job, we have seen an increased emphasis on other factors such as diversity and inclusion, agile working arrangements, work life balance, and sustainable, environmentally focused organisations. Diversity has been a key focus in recent times with candidates preferring to join organisations with diverse senior management teams.

### BONUSES

Bonuses are highly variable across organisations and sectors, especially at the senior end of the market. Although lawyers' bonuses are paid on a discretionary basis (based on various performance related factors), they have the potential to make a significant impact on the total annual compensation package.

### FIXED TERM CONTRACT (FTC)

With IR35 impacting the contracting market, there has been a substantial uplift in FTC hiring across the market. Although contractors may fall into a different tax bracket now, in most cases contractors are eligible for many of the same benefits as permanent lawyers in the business.

A separate section for day rates for FTC hires has not been included as they tend to command similar salaries as their permanent counterparts.
